**RESOLUTION NO. 03-2021- Establishment and Redistricting of Two Wards**

WHEREAS, the Door County Board of Supervisors held a public hearing concerning the Preliminary County of Door Supervisory District Plan on September 21, 2021; and

WHEREAS, The Preliminary County of Door Supervisory District Plan was approved by the County Board on September 21, 2021; and

WHEREAS, the Preliminary County of Door Supervisory District Plan must be sent to Door County municipalities for division of wards,

NOW THEREFORE, BE IT RESOLVED by the Town Board of the Town of Jacksonport Door County, Wisconsin that the Preliminary County of Door supervisory District Plan be and is hereby approved.

BE IT FURTHER RESOLVED that the Town of Jacksonport establish Two (2) Wards described as follows:

Ward One (1) Commencing at the Northwest corner of the Northwest one-quarter of the Northwest one-quarter of Section 6, T29N-R27E, being the intersection of Hillside Rd and Division Rd, thence Easterly along the centerline of Hillside Rd to the Northeast corner of the Northeast one-quarter of the Northeast one-quarter of Section 5, T29N-R27E, thence Southerly along the centerline of Memorial Dr to the intersection of Memorial Dr, Plum Bottom Rd, and County Highway V, thence Easterly along the centerline of County Highway V to the shoreline of Lake Michigan, thence Southerly along the shoreline of Lake Michigan to the Northeastern corner of Government Lot 1, thence Westerly to the Southwest corner of the Southwest one-quarter of the Southwest one-quarter of Section 31, T29N-R27E, thence Northerly along the Town Boundary Line of Jacksonport to the point of beginning.

Ward Two (2) Commencing at the Northwest corner of the Northwest one-quarter of the Northwest one-quarter of Section 4, T29N-R27E, thence Easterly along the Northern Boundary of the Town of Jacksonport to the East lone of Section 1, T29N-R27E, thence Southerly along the Eastern Town of Jacksonport Boundary Line to the shoreline of Lake Michigan, thence Southerly along the shoreline of Lake Michigan to the centerline of Lake Park Dr, thence Westerly along Lake Park Dr into the centerline of County Highway V to the intersection of County Highway V and Memorial Dr, thence Northerly along the centerline of Memorial Dr to the point of the beginning.

BE IT FURTHER RESOLVED that the Town Hall, located at 3365 County Rd V, Town of Jacksonport shall be the official polling place for the Town of Jacksonport Wards 1 and 2 of the County of Door Supervisory District Plan.


